The attention of all the Principals / Correspondents of Private Minority and Non-Minority Colleges in the State are invited to the references read above and they are informed that, the rule 3(ii)(c) of G.O.Ms.No.10 School Education Department dated 12.04.2017 is as follows:

“The Category ‘B’ seats shall be 20% of the total sanctioned intake of seats in D.El.Ed Programme in respect of Private Un-aided Non-Minority and Private Un-aided Minority Elementary Teacher Education Institutions, which shall be open to all the eligible candidates who satisfied the eligibility criteria for admission as mentioned at Rule 4 of these Rules.” and as per Rule 6 of the said Government Orders.

Therefore, all the Principals / Correspondents of Private Minority and Non-Minority D.El.Ed. Colleges in the State are requested to take necessary action for filling up of the **Category – ‘B’ seats (under management quota)** as per **G.O.Ms.No.10, School Education, dated: 12.04.2017.**

3.	Allotments of seats by the Private Managements and they shall select in a fair and transparent manner and publish the Final Lists of selected candidates in their websites / Notice Boards.	on 10.07.2025.

5.	Reporting of the selected candidates to concerned Private D.El.Ed. colleges.	on 14.07.2025.
6.	The Principals of Govt. DIETs are requested to Obtain and Upload the final list of Management Quota seats under Category "B" in the TG DEECET - 2025 website.	on 15.07.2025.
7.	Submission of hard copy of admitted candidates (final list) duly signed by the Principal of Govt. DIETs concerned and submit the same to the Convener, TG DEECET-2025 for verification, by the private Colleges.	on 16.07.2025.

All the Principals / Correspondents of Private Minority and Non-Minority (D.El.Ed.) Colleges in the State are requested to take necessary action, as per rules and as per the schedule for filling up of the Category – 'B' seats, without any deviation.

Further, all the Principals of Government D.I.E.Ts in the State are requested to communicate these Proceedings to all the Managements of Private D.El.Ed. Colleges under their jurisdiction and take necessary action and report compliance. Further, they are also requested to obtain the final lists of selected candidates under management quota seats from the Principals / Correspondents of Private Minority and Non-Minority (D.El.Ed.) Colleges and Upload the same in the TG DEECET -2025 website on or before 15.07.2025, without fail.

Therefore, all the Govt. DIET Principals are requested to oversee and monitor the entire process as per the G.O.Ms.No.10, School Education, dated: 12.04.2017 and as per the above schedule and submit compliance report to the undersigned by 16.07.2025, any deviation in the matter will be viewed seriously.
