The attention of all the Principals / Correspondents of Private Minority and Non-Minority Colleges in the State are informed that, the rule 3(ii)(c) of G.O.Ms.No.10 School Education Department dated 12.04.2017 is as follows:

"The Category B Seats shall be 20% of the total sanctioned intake of seats in D.EI.Ed., Programme in respect of Private Un-aided Minority Elementary Teacher Education Institutions, which shall be open to all the eligible candidates who satisfied the eligibility criteria for admission as mentioned in Rule 4 of these rules." and as per Rule 6 of the said Government Orders.



5.	Reporting to colleges by the candidates	21.01.2021 to 25.01.2021
6.	Uploading of final list of candidates in the TSDEECET -2020 website.	28.01.2021
7.	Submission of hard copy of allotted /admitted candidates (final list) made by the managements to the Convener, DEECET-2020 for verification and for approval	30.01.2021
